

In addition to my daily tasks as the controller, I was also responsible for handling and overseeing the financial books for more than 40 remote locations. This included recording financial transactions (daily sales, accounts receivable, accounts payable and payroll) and reporting financial results in the form of weekly and monthly financial reports back to the 40+ facility owners.

In 2009, I started a new job as an account manager/bookkeeper for an IT and telecommunication reseller where I've managed inventory and continued to offer accounting services through sales entry and order management. It was during this time that I was introduced to QuickBooks and became a Certified QuickBooks Advanced Pro Advisor, and decided to start IM Bookkeeping.
